



Chapter 4

Hualien Branch, Taiwan High Prosecutors Office



Section 1 Historical Overview

For the convenience of the people, the previous Ministry of Judicial Administration (“MOJA”) established the “Provisional Hualien Court and Prosecutors Office of the Taiwan High Court” on May 2, 1965, and was actively preparing for the establishment of the Hualien Branch of the Taiwan High Court and the Department of Prosecution under that Branch.

On July 15, 1972, the “Hualien Branch Court and Department of Prosecution of the Taiwan High Court” was officially established, and the part of the Department of Prosecution was separately renamed as the “Department of Prosecution under the Hualien Branch Court of the Taiwan High Court” after the separation of the court trial system and the prosecution system. On December 24, 1989, the Hualien Prosecutors establishment was renamed to “Hualien Prosecutors Office under the Hualien Branch Court of the Taiwan High Court” in accordance with the amendment of the Court Organization Act. On May 25, 2018, this establishment was again renamed to the “Hualien Branch, Taiwan High Prosecutors Office,” where the wording of “Court” from its organizational name was taken away, in accordance with the amendment of the Court Organization Act.

Section 3 Office Buildings

I. The old office

The original office building was completed in October 1972, where the Hualien Branch Court of the Taiwan High Court and the Department of Prosecution under that Branch had their offices at the same location.

II. Expansion of the office

As the number of cases and working staff increase over the years, the original offices were no longer sufficient, and the office environment was inferior, affecting the work efficiency. Located adjacent to the Hualien Prosecutors Office under the Hualien Branch Court of the Taiwan High Court, the Hualien Branch Court of the Taiwan High Court completed the expansion of its office around 2001. In order to strike a balance between the Court and the Prosecutors Office and to solve the plight of insufficient office space, a plan to improve this Prosecutors Office was drafted and submitted to its superior authority for approval. Parcel No, 1791 located in Mingxiang Section of Hualien County was picked for the construction of the expanded office. After 9 times tender failure, the construction finally commenced on March 28, 2002 and completed on April 30, 2003, and the building was put to use on October 15, 2003.

Section 6 Business Evolutions


I. In order to strengthen services for the people, the "Provisional Taitung Office of the Hualien Prosecutors Office under the Hualien Branch Court of the Taiwan High Court" was newly established On January 22, 1999.

Later, on January 21, 2013, this establishment was renamed "Taitung Prosecutors Office under the Hualien Prosecutors Office under the Hualien Branch Court of the Taiwan High Court," while the name of the "Taitung Court under the Hualien Branch Court of the Taiwan High Court" took effect. On May 25, 2018, this establishment was again renamed "Taitung Prosecutors Office under the Hualien Branch, Taiwan High Prosecutors Office," in accordance with the amendment of the Court Organization Act.

II. On August 1, 2017, the "Eastern Taiwan Regional Anti-Drug Collaborative Unit" was established, where professional manpower was stationed, a district database was built for narcotics production and trafficking, so as to lead and integrate the Anti-drug enforcement affairs of the six major drug enforcement systems.
